

## Early Career Fellowship Grants – February Deadlines

### **Postdoctoral Research Fellowship – [Korea Foundation](#)**

This enables scholars who have recently earned a PhD in a Korea-related topic to undertake research at a university or research organisation located in North America. Research may be in the humanities, social sciences, arts or culture on a Korea-related topic. Applicants must have received their PhD within the past five years and must have citizenship or permanent residency status in a country outside of Korea. Candidates who will receive their PhD degree by 31 August 2019 may also apply. Applicants must not have been awarded a position at a university equivalent or exceeding that of a full-time lecturer, or be designated as a senior researcher of a research institution. Closes 12 February.

### **Postdoctoral Fellowship – [Taiwan Foundation for Democracy](#)**

This enables scholars who have recently received their PhDs to carry out in-depth research related to Taiwan's democratic and human rights development. The foundation encourages applicants to form networks with organisations and institutions dealing with democracy and human rights issues based in Taiwan. Applicants must have received their PhD in any relevant field up to seven years prior to applying. Applications are accepted from anywhere in the world, except Taiwan. The fellowship comprises a monthly stipend of TWD 45,000 designed to assist with living expenses in Taiwan, for visits of up to one year. The cost of one round-trip plane ticket to Taiwan may also be reimbursed, and a shared office space may be provided. Closes 15 February.

### **Ouseley Short-Term Research Fellowship – [University of London](#)**

The Warburg Institute at the University of London invites applications for the Ouseley short-term research fellowship. This enables a scholar to undertake a period of research on the Arabic, Persian, Hindustani and other Oriental languages in the UK. Applicants can be at any stage in their postdoctoral careers. Preference is given to scholars working in areas where the institute already has strengths, such as art, science, philosophy, religion and especially the transmission of ideas between cultures. Those who have previously held a short-term fellowship at the institute are not eligible not eligible to apply and the fellowship must not be held concurrently with another fellowship and award. One fellowship, worth £1,500 per month for between two and three months, is available. Closes 15 February.

### **Religious Studies Department Postdoctoral Fellowship – [University of Virginia](#)**

The University of Virginia, on behalf of its Religious Studies Department, invites applications for its postdoctoral fellowship. This supports research on American religious history, thought or practice. Preference is given to marginal or newer religious movements, especially Mormonism. The fellowship includes teaching and training. Applicants must have completed their PhD by 25 August 2019. The fellowship includes a salary, benefits and USD 3,000 for research. Closes 15 February.

### **Intermediate Fellowships India Alliance – [Wellcome Trust](#)**

The Wellcome Trust's India Alliance invites preliminary applications for their intermediate fellowships. These enable scientists to undertake research and establish themselves as independent researchers in an academic institution in India. The proposed research should fall within the India Alliance's remit, which is to support biomedical research that is relevant to human and animal welfare. Basic science and veterinary researchers with four to 15 years of post-PhD research experience may apply. Typically applicants should have a PhD or equivalent clinical or public health research experience, between four and seven years of postdoctoral research experience and a track record in pursuing innovative research. In the case of clinical or public health researchers, a postgraduate degree in medical or allied health sciences is sufficient. Applicants are advised to choose the most appropriate scheme suitable for them based on their qualifications, research

experience, career trajectory and track record. Host institutions must be based in India, non-profit and financially eligible to receive India Alliance funding and have key research integrity policies in place. All nationalities may apply. Candidates need to be resident in India during the application process and do not need to have undertaken their PhD in India. Holders of established posts in a host institution may apply. The first year and majority of the last year must be spent at the host institution. Time permitted for non-research related activity is normally restricted to eight hours per week. Fellowships are tenable for five years and provide personal support, research expenses, including research assistance, and additional travel allowances. Closes 19 February.

#### **Innovation Fellowships – [Victorian Endowment for Science, Knowledge and Innovation](#)**

The Victorian Endowment for Science, Knowledge and Innovation Veski invites applications for its innovation fellowships. These aim to bring international scientists and researchers in the fields of science and innovative technology to Victoria. Specifically, fellowships will be awarded across areas of: biotechnology; biomedical; advanced manufacturing including food science and bioengineering; digital agriculture; cyber security; environmental and energy technologies; the enabling sciences; space and transportation.

Applications are open to researchers with international recognition and standing in their field and peer group. Applicants must have been working overseas for the past year and must be domiciled outside Australia at the time of application. Veski is actively encouraging applications from individuals with an industrial track record and proven collaborations with industry or who intend to foster stronger industry engagement to deliver innovative solutions through a multidisciplinary approach to problem solving. The fellowships are worth up to AUD 50,000 per year for up to three years. Host organisations are required to match the Veski funding with a cash and in-kind contribution. Closes 21 February.

#### **Robert and Lisa Sainsbury Fellowships – [Sainsbury Institute for the Study of Japanese Arts and Cultures](#)**

The Sainsbury Institute for the Study of Japanese Arts and Cultures invites applications for the Robert and Lisa Sainsbury fellowships. These provide the opportunity to work in a scholarly environment conducive to the completion of a publication project. The aim is to strengthen academic ties with Japanese studies programmes in the US, Canada, Asia, Oceania and Europe. Scholars who have received a PhD in any area of Japanese culture may apply, although preference is given to applications focusing on the history of art, cultural heritage, archaeology, architecture, film studies and digital humanities. Two types of fellowships are available: one-year fellowship worth £24,000; six-month fellowship worth £12,000. Fellows are provided with office space at the institute's headquarters in Norwich. Closes 28 February.

#### **Servier/UIP Research Fellowship – [Servier](#)**

The International Union of Phlebology (UIP) and Servier invite applications for the Servier/UIP research fellowship. This supports original clinical or fundamental research projects in the areas of phlebology and lymphology. Applicants must be medical doctors under 45 years of age, who belong to a national scientific society affiliated to the UIP. The fellowship is worth €25,000. Closes 28 February

#### **EuroTechPostdoc Programme – [EuroTech Universities](#)**

The EuroTech Universities Alliance invites applications for its EuroTechPostdoc programme. This provides fellows with international research and career development opportunities across four technical universities in Europe to further develop their individual potential. Applicants may apply within one of the five focus research areas: health and bioengineering; smart and urban mobility; data science and engineering; high performance computing; entrepreneurship and innovation.

Fellowships are tenable at the following universities: Technical University of Denmark, Ecole Polytechnique Fédérale de Lausanne, Eindhoven University of Technology and Technical University of Munich. Applicants may be citizens of any country, holding a PhD or having at least four years of equivalent research experience. Researchers may not have resided or carried out their main work in the country of the host institution for more than 12 months in the three years immediately prior to the call. Fellowships include a monthly salary based on the salary scale of the host institution and last 24 months. Each participating university grants 10 fellowships. Closes 28 February.

#### **Australian European University Institute Fellowships – [European University Institute, Florence](#)**

The Australian European University Institute Fellowships Association, in collaboration with the European University Institute, invites applications for its fellowships. These enable fellows to carry out research at the European University Institute in Florence, Italy. The following fellowships are available: one one-month visiting scholar fellowship during the period January to June 2020, covering EUI fees; one three-month postgraduate fellowship for the period September to December 2019, covering EUI fees and a one-off payment of AUD 7,000 to contribute to travel and subsistence; one six-month postdoctoral fellowship for the period January to June 2020, covering EUI fees and a one-off payment of AUD 12,000 to contribute to travel and subsistence.

The fellowships are available to researchers currently undertaking research in history, law, economics and social and political science who are able to identify a direct benefit for their research from a period of residence at the EUI. Postgraduate applicants must be at an advanced stage of their research, while the postdoctoral fellowship is available to those who have graduated with a PhD qualification from an Australian university within the last five years and have an affiliation with an Australian university. The visiting scholar fellowship is available to an established scholar whose tenure must be demonstrably beneficial both to the applicant's research and the EUI. Closes 1 March.

#### **Esther Katz Rosen Fund Grants – [American Psychological Association](#)**

The American Psychological Association invites applications for the Esther Katz Rosen Fund grants. These support activities related to the psychological understanding of gifted children and youth. The main goals are to: enable and enhance the development of identified gifted and talented children and adolescents; encourage promising psychologists to continue innovative research and programmes in this area.

Applicants must be affiliated with a school or education institution and hold a doctoral degree from, or be a graduate student at, an accredited university. Early career psychologists with 10 years or less of postdoctoral experience and graduate students are particularly encouraged to apply. Pilot projects with the potential to secure funding from major federal and foundation funding agencies may also be supported. Grants are worth between USD 1,000 and USD 50,000 each. Closes 1 March.

#### **Synthetic Biology Future Science Fellowships – [Commonwealth Scientific and Industrial Research Organisations](#)**

The Commonwealth Scientific and Industrial Research Organisation invites applications for its synthetic biology future science fellowships. These support early-career researchers in undertaking research projects that will build Australian capacity in synthetic biology while employed at Australian host organisations. Project proposals in the social sciences, as well as lab-based research, are encouraged. Applications are invited across the domains of integrative biological modelling, engineering novel biological components and assembling novel biosystems and should align with one of the following application domains, of which the last two will be prioritised: foundation technologies; environment and biocontrol; chemicals and fibres; health; maximising impact. Fellowships will be hosted at an Australian university or research organisation. Applicants must hold a PhD conferred between 1 July 2011 and 1 July 2019. Applicants may be Australian or international, and for university-hosted applicants, the scheme is open to researchers at academic levels A and B.

Interdisciplinary, inter-institutional and international collaborations are encouraged. Fellowships provide three years of salary and operating expenses, which may be used for experimental costs, equipment, travel, and other expenses. Matching co-funding by the host organisation is required. Closes 1 March.
